Northern Tier Regional Planning and Development Commission (NTRPDC) submitted a single application on behalf of the Blossburg Police Department requesting \$5,000.00 in grant assistance for new equipment to ensure a safe community. The grant is through The Department of Community and Economic Development (DCED).
