Previous to tonight's meeting, Mrs. McNamara sent a letter to Borough Councilmembers explaining "The Farmers' Market Development Grant". This grant needed to be submitted to United States Department of Agriculture by February 6, 2008. The grant was submitted on February 5, 2008. "The Farmers' Market Development Grant", in the amount of \$10,000.00, would be used to promote the current Farmers' Market, develop a community garden, provide vendor shelter, and used to educate the community. The proposed garden site is to be located on the empty lots at North Main Street that is owned by the Blossburg Borough. Due to the fact these properties are in the flood plain, V.I.B.E. realizes the building restrictions on these properties. No structures will be built, other than raised garden beds. The farmers market would move from Riverside Plaza to the community garden location. If the grant is awarded and permission is given by Council to use the above properties, insurance will be purchased by V.I.B.E. Councilmember James Bogaczyk made a motion to support V.I.B.E. on the proposed Farmers' Market Development Grant and the use of the vacant North Main Street properties; second, Cheryl Bubacz. All in favor.

3. Outside Wood Burning Stoves:
