# BLOSSBURG BOROUGH COUNCIL MEETING June 10, 2013

Pledge of Allegiance recited.

Council President Thomas Bogaczyk called the Blossburg Borough Council regular meeting to order at 6:30 P.M. in the Council Room of the Borough Building, 245 Main Street, Blossburg, PA.

**Guests:** Shawn Carey attended meeting to discuss his property located at 219 South Williamson

Road. Mr. Carey would like to have a 30' x 40' steel structure built and use the building as a repair garage business. In October 2012 the Blossburg Borough Planning Commission denied Mr. Carey's request, because of zoning issues (spot zoning) and no towed vehicles at the premise. The property is zoned R – Residential. Councilmembers suggested Mr. Carey request a Zoning Board meeting, since a zoning change would be required for this location.

Zoning Fees are \$250.00.

Lynne Thompson told Council all went well at the banner dedication, which was held on May 27, 2013 and 300 people <u>+</u> attended. More banners are being printed and more applications are coming in.

Mrs. Thompson made comments on possible decisions to be made by the Southern Tioga School Board. The closing of North Penn High School is a serious situation. Mrs. Thompson stressed the importance of local residents and Councilmembers attendance at the School Board meetings in support of our Blossburg schools. Mrs. Thompson recognizes Southern Tioga School Board Meetings are held the same date and times as Blossburg Borough Council Meetings, but suggested with changing the Council meeting date Councilmembers would be able to attend the School Board meetings. Councilmembers decided to wait until next month's meeting and evaluate if the Council meeting date will be changed.

leveling streets before work begins.
